The highlights of our fiscal and fourth quarter financial results are:

- Q4 Revenue of \$126.1million, up 2.7% from \$122.7 million in Q4 of last year
- Q4 Adjusted Net Income (ANI) of \$22.9million, compared to \$20.9 million Q4 last year
- Added six new clients in the quarter, expanded five existing relationships and renewed 13 contracts
- Day Sales Outstanding (DSO) at 28 days
- Fiscal 2015 Full Year Revenue less repair payments of \$503.0 million, up 6.7% from \$471.5 million in fiscal 2014

While 80 percent of companies place a lot of emphasis on capturing early payment discounts, research shows that only 27

percent are able to capture all the discounts available, for various reasons such as:

Companies may be unable to process invoices fast enough, with a large percentage of paper invoices being past due when they arrive in Accounts Payable (AP)

Organizations may not be able to conduct the spend analysis necessary to maximize discount capture, including understanding Purchase Order (PO) penetration rates, current terms of payment across suppliers and the prevalence of discount-free early payment
